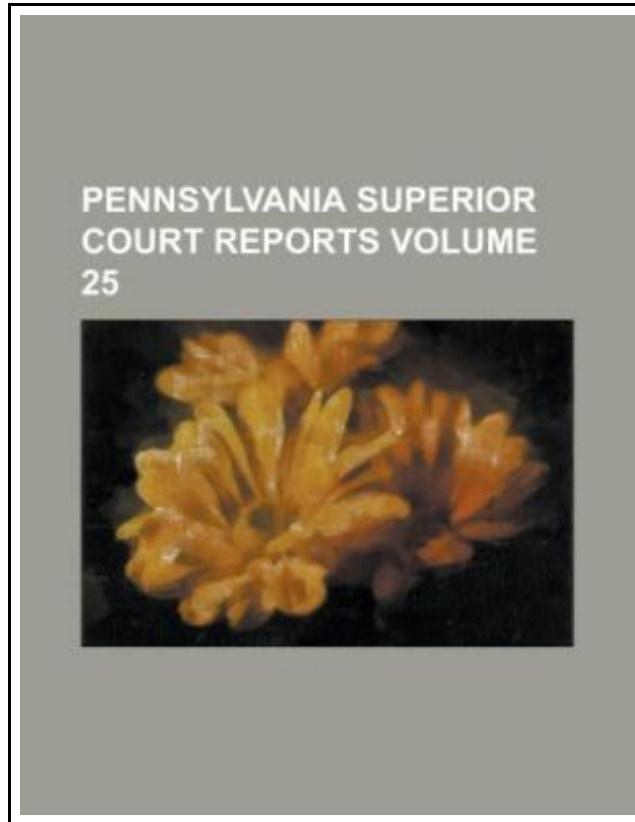

The court of quarter sessions did not have jurisdiction to appoint viewers to assess damages for an actual cutting of the Opinion of the Court. 25 Pa.
