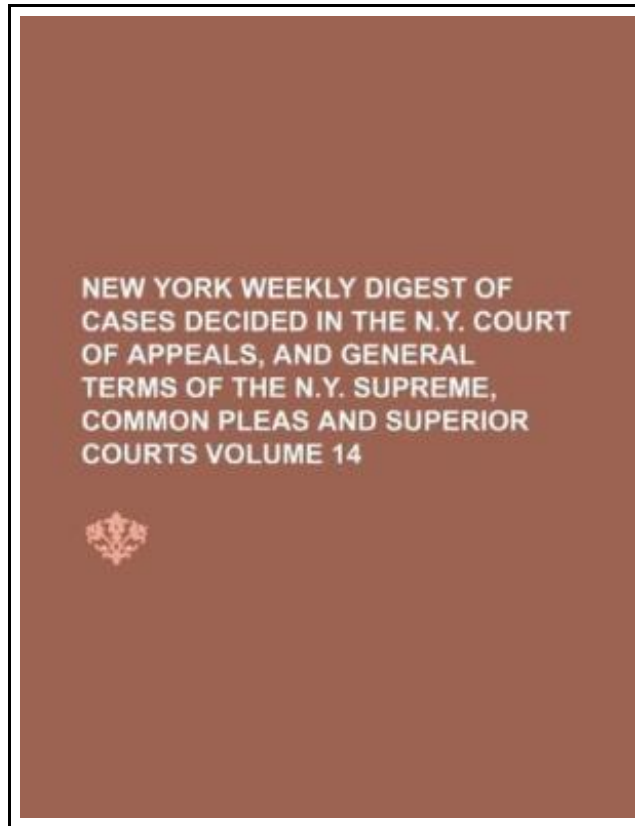

Not illustrated. 1882 Excerpt: .to levy an assessment on stockholders to pay debts based on the aggregate indebtedness, without regard to such limitation on their liability, and the fact that it is made pursuant to an order of the court obtained by the receiver does not make it conclusive on the stockholders as to the amount of their liability. In a case where the dissolution of the corporation was voluntary, evidence that prior thereto the company had made fraudulent preferences is admissible in an action brought by the receiver against a stockholder to recover on an assessment to pay debts. The proceedings for dissolution may be attacked by proof of any fact showing that the company was not one of those empowered to avail itself of the act of 1853. Chap. 361, Laws of 1852, has no application to corporations formed under the act of 1848. This action was brought to enforce the statutory liability of a stockholder of an insolvent manufacturing company for the payment of its corporate debts. On August 29, 1874, by resolution of its trustees the company was dissolved, and in 1876, on petition of the surviving trustees and the creditors, plaintiff was appointed receiver. On July 21, 1876, an order was made directing an assessment upon the stockholders of 75 per cent. The complaint averred that the property and assels of the com i pany are insufficient to pay its just debts due within one year from the time they were contracted and which became...
